RULES, GUIDELINES, PROMOTION & COMPETITION DETAILS

RULES AND GUIDELINES

1. **Eligibility:**
 - a. The competition is open to Trinidad and Tobago nationals aged 13 - 19.
 - b. Staff of the TTSEC and their immediate family members are not eligible to participate.
 - c. Winners of past TTSEC online investing competitions are not eligible to participate.
2. **Competition Duration:**
 - a. The competition will run for eight weeks, from **February 10 to April 4, 2025**.
3. **Registration:**
 - a. Registration is open from **January 27 to February 7, 2025**.
 - b. Students must register within the period to be eligible to compete.
 - c. Students must join the “***INVEST. GROW. LEARN***” - ***SCHOOL QUEST*** to play and compete on February 10th to April 4th 2025.
 - d. Note, before February 10th, Students will see the School Quest under the “Coming Soon” section on the website.
4. **Consent and Agreement:**
 - a. Winners, and in the case of minors aged 13-17, their parents/guardians, must sign a legal agreement consenting to the competition’s terms and conditions.
5. **Identification and Verification:**
 - a. Winners must provide valid identification and proof of age and nationality upon request. Failure to do so may result in forfeiture of prizes.
6. **Prize Conditions:**
 - a. All prizes must be invested in the local securities market.
 - b. Prizes are non-transferable.
 - c. Proof of investment must be submitted to the TTSEC within three (3) months of prize receipt.

7. **Disqualification:**

- a. The TTSEC reserves the right to refuse, reject, or disqualify any participant found in violation of the competition guidelines.

8. **Technical Issues:**

- a. The TTSEC is not responsible for technical issues such as system downtime or internet connectivity problems that may affect a participant's performance.

9. **Amendments:**

The TTSEC reserves the right to amend the Rules and Guidelines at any time. Changes will be communicated via official TTSEC channels.

COMPETITION DETAILS

1. **Market Scenarios and News Alerts:**

- o Throughout the competition, participants will receive market scenarios and news alerts.

2. **Portfolio Management:**

- o Participants are urged to manage their investment portfolios wisely to maximise their investment potential.

3. **Leaderboard:**

- o The **Virtual Leaderboard** will be visible to all participants, allowing them to track their progress and compare it with competitors.

4. **Active Trading**

- o Participants must actively trade¹ **at least twice per week** (i.e., buy or sell transactions must occur 2 times each week) throughout the eight-week competition period to be eligible for prizes. This amounts to a minimum of (16) trades in total. Failure to do so will disqualify students from the prize winnings.

5. **Weekly Breakdown for Active Trading:**

- o Week 1: February 10, 2025
- o Week 2: February 17, 2025
- o Week 3: February 24, 2025
- o Week 4: March 3, 2025
- o Week 5: March 10, 2025
- o Week 6: March 17, 2025
- o Week 7: March 24, 2025
- o Week 8: March 31, 2025

6. **Adherence to Rules & Guidelines:**

- o All participants are subject to the competition guidelines and must comply to remain eligible.

¹ Executing at least one buy or sell transaction on the stock market simulator during a trading session.

2. The transactions should involve real-time or simulated buying or selling of stocks or other securities listed in the competition.

3. Participants must ensure they engage in trading activities on two (2) distinct/separate days within any given week. Simply holding a position without any buy/sell action would not count as active trading for that day.

PROMOTIONS

Promotion:

- The competition will be promoted via TTSEC's digital and social media platforms, through email marketing to all secondary schools in Trinidad and Tobago, on radio and in the print media.

Media and Publications:

- Winners may be featured in the media and/or future TTSEC publications or programmes.

Winner Announcement:

- Winners will be determined and announced via social media within 48 hours of the competition's closure. TTSEC's decision is final.
